Llais is an independent statutory body, set up by the Welsh Government to give people of Wales much more say in the planning and delivery of their health and social care services – locally, regionally, and nationally.

As part of our local workplan, Llais Gwent Region has committed to engage with people at the point they are receiving a health and social care service. Therefore, we arranged for two of our visiting volunteers to attend Penpergwm Home (Residential Home) to speak with people who reside there, to gain their feedback about what it's like for them to stay at Penpergwm House, and their access to health and social care services.

Penpergwm House Residential Home is a family run care home in the heart of Monmouthshire (between Abergavenny & Raglan). Penpergwm House offers 34 rooms to accommodate clients. Both permanent places and short stay/respite placements are available, and visitors are welcomed at any time that suits their clients – not the home.¹

In July 2023, our Public Engagement, Monitoring and Scrutiny Officer, and Regional Director were invited to visit Penpergwm House, and were given a tour of the home by the Residential Manager.


Following this, our volunteers were invited to attend Penpergwm House to speak with their residents. We were careful not to disrupt mealtimes.

On Monday 16th of October 2023, two of our visiting volunteers attended Penpergwm House, and had a tour of the home by the Residential Manager. Our volunteers spoke to four clients who were happy to give their feedback about what it's like to live at Penpergwm House.

This briefing contains a summary of the feedback that people gave during our visit.

Four people who reside at Penpergwm Home happily engaged with our visiting volunteers and had a conversation about living at Penpergwm House.

To ensure we were engaging with clients appropriately, our visiting volunteers did not take surveys to complete. Instead, 'prompt' questions were given to start a spontaneous and natural conversation.

Overall, clients at Penpergwm House said they are very happy residing there. People told us they felt "safe" and "content", whilst others told us it "feels like home".

If people needed to access NHS or social care services, this was arranged for them by staff.

People found staff friendly and approachable, and one person told us that staff were always happy to listen to them.

There were activities for people to participate in at Penpergwm House, one person told us they do not participate in the activities, but they were happy sitting in the day room to have tea.

Clients were satisfied with the food and drinks offered at Penpergwm Home; one person told us there was "lots of lovely homemade food".

Further comments:

"Would rather be here than at home alone".

"Good people - can't expect too much".
